**CLASS 4 VENUE LICENCE**

Pursuant to **Section 67** of the **Gambling Act 2003** ("the Act"), the Secretary for Internal Affairs hereby grants a Class 4 Venue Licence to:

**HUCKLEBERRYS SPORTS & CHARITABLE SOCIETY INC** ("the corporate society")

authorising it to conduct Class 4 gambling by way of gaming machines at the following venue for the sole objective of distributing the net proceeds from the gambling to the following authorised purpose(s):

1. **DONATIONS TO AMATEUR SPORTS TEAMS AND CLUBS IN THE LOCAL AREA, COMPETING IN RECOGNISED LEAGUES AND TOURNAMENTS. GRANTS ONLY ISSUED TO SPORTS TEAMS AND CLUBS WHICH ARE FORMALLY ESTABLISHED AND/OR LEGALLY CONSTITUTED. GRANTS ISSUED FOR ACTUAL AND REASONABLE TRAVEL EXPENSES FOR GROUPS PARTICIPATING IN TOURNAMENTS WITH KINDRED GROUPS, SPORTS EQUIPMENT, PLAYING UNIFORMS AND GROUND HIRE. NO GRANT SHALL BE ISSUED TO ANY PLAYER OR TEAM COMPETING ON A PROFESSIONAL BASIS.**
2. **DONATIONS TO RECOGNISED CHARITABLE AND CULTURAL ORGANISATIONS WITHIN THE LOCAL COMMUNITY TO FURTHER THE OBJECTIVES OF THESE GROUPS.**
3. **DONATIONS FOR EDUCATIONAL ADVANCEMENT THROUGH GRANTS TO SCHOOLS OR OTHER EDUCATIONAL INSTITUTES FOR EQUIPMENT OR THE DEVELOPMENT OF BETTER STUDENT AMENITIES NOT COVERED BY GOVERNMENT FUNDING. THE ESTABLISHMENT OF STUDENT SCHOLARSHIPS, BURSARIES OR GRANTS TO ASSIST INDIVIDUAL STUDENTS IN THEIR GENERAL EDUCATION ADVANCEMENT OR FOR THE FURTHERING OF ACADEMIC SPECIALISATION, PROVIDED SUCH STUDENTS ARE SELECTED IN A FAIR AND OPEN MANNER AFTER PUBLIC ADVERTISING.**
4. **NO GRANT SHALL BE ISSUED TO ANY PARTY WHICH WILL RESULT IN COMMERCIAL ADVANTAGE, EITHER DIRECTLY OR INDIRECTLY, TO MEMBER SITES OF HUCKLEBERRY'S SPORTS AND CHARITABLE SOCIETY.**

The holder of this Class 4 Venue Licence is authorised to conduct Class 4 gambling by way of gaming machines at the venue specified on this licence by operating no more than **18** gaming machines.

The holder of this Class 4 Venue Licence is authorised to operate the gambling equipment specified in the Schedule attached to this licence.

**CLASS 4 VENUE LICENCE - CONDITIONS**

applying to:

**FOUR FISH****(Issued pursuant to Section 70 of the Gambling Act 2003)****Condition 1 - Primary activity must be available**

The holder of a class 4 venue licence must not conduct class 4 gambling at the venue specified on the licence unless the primary activity at the venue is offered and available at that time.

**Condition 2 - Licence must be displayed**

The holder of a class 4 venue licence must ensure that the class 4 venue licence is at all times displayed in clear view of the public and in close proximity to the gaming machines at the relevant venue.

**Condition 3 - Change of details**

- (1) The holder of a class 4 venue licence must, as soon as practicable, advise the Secretary, and provide new contact details, if there are changes to the postal address and/or telephone number of a venue operator and/or venue manager;
- (2) If the holder of a class 4 licence makes substantive changes to a venue agreement, the licence holder must, as soon as practicable:
  - (a) advise the Secretary that amendments have been made to a venue agreement; and
  - (b) provide the Secretary with a copy of the amended agreement or the parts of the agreement that have been amended.

**Condition 4 - Late banking**

The holder of a class 4 operator's licence must:

- (a) immediately notify the Secretary if gaming machine proceeds relating to a venue are not banked in accordance with Regulation 4 of the Gambling (Class 4 Banking) Regulations 2006; and
- (b) immediately cease the conduct of class 4 gambling at the venue until the outstanding proceeds are banked; and
- (c) use all reasonable endeavours, including civil or criminal proceedings to recover the outstanding proceeds.
